- The Bulgarian consumer electronics retail market recorded revenues of \$3.0 billion in 2023, representing a compound annual growth rate (CAGR) of 9.4% between 2018 and 2023.
- The communications equipment segment accounted for the market's largest proportion in 2023, with total revenues of \$1.1 billion, equivalent to 36.0% of the market's overall value.
- In 2023, the Bulgarian consumer electronics retail market recorded an annual growth of 8.6%. The growth is attributed to the increase in penetration of personal computers for work, education, and entertainment supported market growth. According to the Organization for Economic Co-operation and Development (OECD), in 2023, households with personal computers in Bulgaria reached 2.4 million, up 3.0% annually.
