- The communications equipment segment accounted for the market's largest proportion in 2023, with total revenues of \$10.7 billion, equivalent to 34.2% of the market's overall value.
- In 2023, the Canadian consumer electronics retail market recorded an annual growth of 1.8%. The growth is attributed to the growing trends in digital entertainment and home-based leisure activities which boosted the demand for consumer electronics such as TVs, gaming consoles, and audio systems.
