- Rising consumer confidence is a key driver for the consumer electronics retail market, as consumers are more inclined to invest in the latest gadgets and devices that enhances their lifestyle. According to the Organisation for Economic Co-operation and Development (OECD), the consumer confidence index in Denmark reached 98.81 in August 2023, up from 96.28 in August 2022.
