- The communications equipment segment accounted for the market's largest proportion in 2023, with total revenues of \$1.2 billion, equivalent to 31.1% of the market's overall value.
- The Finnish consumer electronics retail market experienced a downturn in 2023 due to rising inflation which has significantly eroded consumers' purchasing power. According to the Statistics Finland, in 2023, the consumer price inflation in Finland reached 6.3%, up from 1.1% in 2018.
