- The Hungarian consumer electronics retail market recorded revenues of \$3.4 billion in 2023, representing a compound annual growth rate (CAGR) of 3.7% between 2018 and 2023.
- The communications equipment segment accounted for the market's largest proportion in 2023, with total revenues of \$1.3 billion, equivalent to 39.1% of the market's overall value.
- Rising consumer confidence is a key driver for the consumer electronics retail market, as consumers are more inclined to invest in the latest gadgets and devices that enhances their lifestyle. According to the Organisation for Economic Co-operation and Development (OECD), the consumer confidence index in Hungary reached 99.02 in August 2023, up from 97.68 in August 2022.
