- The household appliances segment accounted for the market's largest proportion in 2023, with total revenues of \$2.1 billion, equivalent to 48.0% of the market's overall value.
- In 2023, the Israeli consumer electronics retail market recorded an annual contraction of 21.7% due to the decline in disposable income. According to the Central Bureau of Statistics, Israel, in 2023, the net disposable income per household in Israel reached \$87,836.1, down 7.4% over 2022.
