- The communications equipment segment accounted for the market's largest proportion in 2023, with total revenues of \$1.7 billion, equivalent to 31.7% of the market's overall value.
- In 2023, the Czech consumer electronics retail market recorded an annual growth of 3.1%. The growth is attributed to the increase in penetration of personal computers for work, education, and entertainment supported market growth. According to OECD, in 2023, households with personal computers in Czech Republic reached 4.1 million, up 2.3% annually.
