- The computer hardware & software segment accounted for the market's largest proportion in 2023, with total revenues of \$125.1 billion, equivalent to 33.3% of the market's overall value.
- In 2023, the US consumer electronics retail market contracted due to the rise in consumer price inflation which reduced consumer spending on discretionary items, such as new electronics. According to the Bureau of Labor Statistics, US, in 2023, the consumer price inflation in the US reached 4.1%, up from 2.5% in 2018.
