Market volume represents the consumption of packaging products in a specific year, while the market value is calculated by multiplying the average manufacturer's price of packaging materials by the market volume.
- The Singaporean containers & packaging market recorded revenues of \$0.5 billion in 2023, representing a compound annual growth rate (CAGR) of 2.6% between 2018 and 2023.
- Market consumption volume increased with a CAGR of 1.5% between 2018 and 2023, to reach a total of 0.4 million tonnes in 2023.
- The economic situation in Singapore contributed to the decline in the market in 2023. Rising raw material costs, driven by global supply chain disruptions and inflation, have pushed up production costs
