- The fish & seafood market consists of the retail sale of ambient fish & seafood, frozen fish & seafood, fresh fish & seafood (counter), chilled raw packaged fish & seafood - processed, chilled raw packaged fish & seafood - whole cuts and dried fish & seafood. The market is valued according to retail selling price (RSP) and includes any applicable taxes. All currency conversions have been made using constant annual average 2023 exchange rates.
- The Canadian Fish & Seafood market had total revenues of \$2,858.5 million in 2023, representing a compound annual growth rate (CAGR) of 3.6% between 2018 and 2023.
- Market consumption volumes declined with a negative CAGR of 0.1% between 2018 and 2023, to reach a total of 182.2 million kilograms in 2023.
- The performance of the market is forecast to decelerate, with an anticipated CAGR of 3.2% for the five-year period 2023-28, which is expected to drive the market to a value of \$3,341.4 million by the end of 2028.
