- The Italian Fish & Seafood market had total revenues of \$14,446.7 million in 2023, representing a compound annual growth rate (CAGR) of 3.1% between 2018 and 2023.
- Market consumption volume increased with a CAGR of 0.2% between 2018 and 2023, to reach a total of 771.2 million kilograms in 2023.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 3.3% for the five-year period 2023-28, which is expected to drive the market to a value of \$17,009.0 million by the end of 2028.
