- The fish & seafood market consists of the retail sale of ambient fish & seafood, frozen fish & seafood, fresh fish & seafood (counter), chilled raw packaged fish & seafood processed, chilled raw packaged fish & seafood whole cuts and dried fish & seafood. The market is valued according to retail selling price (RSP) and includes any applicable taxes. All currency conversions have been made using constant annual average 2023 exchange rates.
- The Singaporean Fish & Seafood market had total revenues of \$829.9 million in 2023, representing a compound annual growth rate (CAGR) of 3.2% between 2018 and 2023.
- Market consumption volume increased with a CAGR of 1.1% between 2018 and 2023, to reach a total of 51.6 million kilograms in 2023.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 3.2% for the five-year period 2023-28, which is expected to drive the market to a value of \$969.6 million by the end of 2028.
