- The Bulgarian food & grocery retail market recorded revenues of \$17.1 billion in 2023, representing a compound annual growth rate (CAGR) of 9.4% between 2018 and 2023.
- The food segment accounted for the market's largest proportion in 2023, with total revenues of \$12.2 billion, equivalent to 71.3% of the market's overall value.
- Rising consumer confidence is a key driver for the food & grocery retail market, as consumers are more willing to spend on higher-quality products that align with their lifestyle and health priorities. According to the National Statistical Institute, the consumer confidence indicator in Bulgaria reached -28.7 points in Q2 2023, up from -36.5 points in Q2 2022.
