- The food segment accounted for the market's largest proportion in 2023, with total revenues of \$101.9 billion, equivalent to 79.2% of the market's overall value.
- In 2023, the Filipino food & grocery retail market recorded an annual growth of 4.2% due to the rise in final household consumption expenditure on food. According to the National Statistics Office - Philippines, in 2023, the final household consumption expenditure on food per household in the Philippines reached \$5,158.3, up 7.1% annually.
