- The food segment accounted for the market's largest proportion in 2023, with total revenues of \$29.3 billion, equivalent to 69.4% of the market's overall value.
- Rising consumer confidence is a key driver for the food & grocery retail market, as consumers are more willing to spend on higher-quality products that align with their lifestyle and health priorities. According to the Organisation for Economic Co-operation and Development (OECD), the consumer confidence index in Sweden reached 95.86 in August 2023, up from 94.50 in August 2022.
