- Foodservice is defined as the total value of all food and drink, including on-trade drinks consumed without food, which is intended for immediate consumption either on the premises, in designated eating areas shared with other foodservice operators, or as takeaway transactions involving freshly prepared food for immediate consumption.
- The European foodservice industry recorded revenues of \$845.1 billion in 2023, representing a negative compound annual growth rate (CAGR) of 0.1% between 2018 and 2023.
- Industry consumption volume increased with a CAGR of 0.1% between 2018 and 2023, reaching 88.7 billion transactions in 2023.
- France held the largest share of 18.2% of the European foodservice industry in 2023, followed by Italy at 16.7%, Spain at 14.6%, the UK at 12.2%, and Germany at 10.5%.
