- The Russian foodservice industry recorded revenues of \$12.6 billion in 2023, representing a negative compound annual growth rate (CAGR) of 3.4% between 2018 and 2023.
- Industry consumption volumes declined with a negative CAGR of 0.4% between 2018 and 2023, to reach a total of 2.9 billion transactions in 2023.
- Russia held a 1.5% share of the European foodservice industry, in 2023, despite being the largest country in Europe by size and population.
