- Foodservice is defined as the total value of all food and drink, including on-trade drinks consumed without food, which is intended for immediate consumption either on the premises, in designated eating areas shared with other foodservice operators, or as takeaway transactions involving freshly prepared food for immediate consumption.
- The Scandinavian foodservice industry recorded revenues of \$38.3 billion in 2023, representing a negative compound annual growth rate (CAGR) of 0.3% between 2018 and 2023.
- Industry consumption volume increased with a CAGR of 0.3% between 2018 and 2023, reaching a total of 3.6 billion transactions in 2023.
- Sweden held the largest share of 35.5% of the Scandinavian foodservice industry in 2023, followed by Denmark at 29.5%, Finland at 19.7%, and Norway at 15.3%.
