- The South African foodservice industry recorded revenues of \$30.6 billion in 2023, representing a negative compound annual growth rate (CAGR) of 3.2% between 2018 and 2023.
- Industry consumption volume increased with a CAGR of 3.1% between 2018 and 2023, reaching 8.1 billion transactions in 2023.
- South Africa held a share of 0.7% of the global foodservice industry in 2023.
