- The Turkish foodservice industry recorded revenues of \$23.6 billion in 2023, representing a negative compound annual growth rate (CAGR) of 8.7% between 2018 and 2023.
- Industry consumption volume increased with a CAGR of 2.6% between 2018 and 2023, reaching 8.1 billion transactions in 2023.
- Turkey held a share of 2.8% of the European foodservice industry, in 2023.
