It typically consists of a console unit and a controller and is connected to a display device such as a television or monitor. Market volume refers to the total number of units of game consoles sold by Nintendo, Microsoft, and Sony through the sales of their respective home entertainment and handheld consoles, including hybrid models that were introduced in 2017 within a year. The market scope excludes game titles, system updates, subscription services, etc. Market value is calculated by multiplying market volume with the average retail prices.
- The German games consoles market had total revenues of \$1,427.7 million in 2023, representing a compound annual growth rate (CAGR) of 11.5% between 2018 and 2023.
- Market consumption volumes declined with a CAGR of -0.4% between 2018 and 2023, to reach a total of 3,076.0 thousand units in 2023.
- Germany accounted for 22.9% of the European games consoles market in 2023.
