- The accessories segment accounted for the market's largest proportion in 2023, with total revenues of \$3,151.9 million, equivalent to 70% of the market's overall value.
- In 2023, the Spanish jewelry & watch retail market recorded an annual growth of 6.8%, fueled by factors such as declining unemployment, an improved standard of living, and a rising consumer confidence index.
