- Market consumption volumes declined with a negative CAGR of 2.3% between 2018 and 2023, to reach a total of 239.2 million units in 2023.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 52.5% for the five-year period 2023-28, which is expected to drive the market to a value of \$71,385.1 million by the end of 2028.
