- Market consumption volume increased with a CAGR of 2.4% between 2018 and 2023, to reach a total of 196.7 million units in 2023.
- The performance of the market is forecast to decelerate, with an anticipated CAGR of 4.3% for the five-year period 2023-28, which is expected to drive the market to a value of \$2,489.8 million by the end of 2028.
