- The Mexican Make-Up market had total revenues of \$1,673.0 million in 2023, representing a compound annual growth rate (CAGR) of 0.4% between 2018 and 2023.
- Market consumption volumes declined with a negative CAGR of 2.6% between 2018 and 2023, to reach a total of 174.3 million units in 2023.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 5.8% for the five-year period 2023-28, which is expected to drive the market to a value of \$2,2218.0 million by the end of 2028.
