The market is valued according to retail selling price (RSP) and includes any applicable taxes. All currency conversions have been made using constant annual average 2023 exchange rates.
- The South African Make-Up market had total revenues of \$310.2 million in 2023, representing a compound annual growth rate (CAGR) of 4.8% between 2018 and 2023.
- Market consumption volumes declined with a negative CAGR of 0.1% between 2018 and 2023, to reach a total of 43 million units in 2023.
- The performance of the market is forecast to follow a similar pattern with an anticipated CAGR of 2.8% for the five-year period 2023-28, which is expected to drive the market to a value of \$356.6 million by the end of 2028.
