- The South Korean Make-Up market had total revenues of \$2,518.4 million in 2023, representing a compound annual growth rate (CAGR) of 3.5% between 2018 and 2023.
- Market consumption volume increased with a CAGR of 2.1% between 2018 and 2023, to reach a total of 145.5 million units in 2023.
- The performance of the market is forecast to decelerate, with an anticipated CAGR of 1.6% for the five-year period 2023-28, which is expected to drive the market to a value of \$2,721.4 million by the end of 2028.
