- The UK Make-Up market had total revenues of \$2,616.2 million in 2023, representing a negative compound annual growth rate (CAGR) of 0.3% between 2018 and 2023.
- Market consumption volumes declined with a negative CAGR of 3.5% between 2018 and 2023, to reach a total of 237 million units in 2023.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 2.9% for the five-year period 2023-28, which is expected to drive the market to a value of \$3,022.4 million by the end of 2028.
