- The apparel retail segment accounted for the sector's largest proportion in 2023, with total revenues of \$1.8 billion, equivalent to 36.2% of the sector's overall value.
- Rising consumer confidence is a key driver for the online retail sector, as it encourages consumers to spend more on a wide range of products that enhance their convenience and lifestyle. According to the Organisation for Economic Co-operation and Development (OECD), the consumer confidence index in Greece reached 99.52 in August 2023, up from 97.03 in August 2022.
