- In Singapore, the publishing market is highly digitalized, reflecting the country's status as a technological hub. The tech-savvy population shows a strong preference for e-books and online subscriptions, supported by excellent internet infrastructure and government initiatives promoting digital literacy. The World Bank reports that the proportion of internet users in Singapore's total population reached 96.7% in 2023, up from 95.9% the previous year.
