- Market consumption volume increased with a CAGR of 1% between 2018 and 2023, to reach a total of 396.9 million kilograms in 2023.
- The performance of the market is forecast to decelerate, with an anticipated CAGR of 2.6% for the five-year period 2023-2028, which is expected to drive the market to a value of \$1,908.0 million by the end of 2028.
