Summary

- The Indonesian Soups market had total revenues of \$9.4 million in 2023, representing a compound annual growth rate (CAGR) of 9.5% between 2018 and 2023.
- Market consumption volume increased with a CAGR of 5.9% between 2018 and 2023, to reach a total of 1.3 million kilograms in 2023.
- The performance of the market is forecast to decelerate, with an anticipated CAGR of 10.1% for the five-year period 2023-28, which is expected to drive the market to a value of \$15.2 million by the end of 2028.
