- Market consumption volume increased with a CAGR of 4.6% between 2018 and 2023, to reach a total of 1,751 million kilograms in 2023.
- The performance of the market is forecast to decelerate, with an anticipated CAGR of 4.2% for the five-year period 2023-28, which is expected to drive the market to a value of \$10,754.3 million by the end of 2028.
