- In 2023, the Indian utilities industry witnessed an annual growth of 1.0% due to the expansion of the country's manufacturing sector which boosted the consumption of electricity, water, and gas. According to the Ministry of Statistics and Program Implementation (MoSPI), in December 2023, India's manufacturing sector output recorded a growth of 3.9%.
