- The gas utilities segment accounted for the industry's largest proportion in 2023, with total revenues of \$295.1 billion, equivalent to 68.4% of the industry's overall value.
- In 2023, the Italian utilities industry recorded an annual contraction of 2.9% due to the decline in energy price inflation. According to the Organization for Economic Co-operation and Development (OECD), in 2023, the Italian energy price inflation reached 17.1%, down from 50.8% in 2022.
