Market volumes refer to the total number of subscriptions for each of these services. Market shares are in terms of subscription volumes. Regional market shares are at a parent company level.
- The Australian wireless telecommunication services market recorded revenues of \$9.1 billion in 2023, representing a negative compound annual growth rate (CAGR) of 2.4% between 2018 and 2023.
- The market consumption volume increased with a CAGR of 3.3% between 2018 and 2023, to reach a total of 41.4 million subscriptions in 2023.
- The growth of the Australian market is driven by rising mobile penetration and internet usage. In 2023, internet users accounted for 97% of the total population, while mobile penetration reached 107.3 per 100 people, according to GlobalData.
