- The German wireless telecommunication services market recorded revenues of \$21.4 billion in 2023, representing a negative compound annual growth rate (CAGR) of 0.8% between 2018 and 2023.
- The market consumption volume increased with a CAGR of 5.8% between 2018 and 2023, to reach a total of 171.9 million subscriptions in 2023.
- The growth of the German market is driven by rising mobile penetration and internet usage. In 2023, internet users accounted for 92.6% of the total population, while mobile penetration reached 125.3 per 100 people, according to GlobalData.
