- The Indian wireless telecommunication services market recorded revenues of \$27.7 billion in 2023, representing a compound annual growth rate (CAGR) of 3.7% between 2018 and 2023.
- The market consumption volumes declined with a negative CAGR of 0.4% between 2018 and 2023, to reach a total of 1,150.7 million subscriptions in 2023.
- The growth of the Indian market is driven by rising mobile penetration and internet usage. In 2023, internet users accounted for 53% of the total population, while mobile penetration reached 81.9 per 100 people, according to GlobalData.
