#### Summary

- The wireless telecommunications services market includes cellular (mobile) phones, pagers, and any other wireless or cellular telecommunication service. Market values represent revenues based on payments to operators of all of these services for subscriptions and usage. Market volumes refer to the total number of subscriptions for each of these services. Market shares are in terms of subscription volumes. Regional market shares are at a parent company level.
- The Kazakhstani wireless telecommunication services market recorded revenues of \$1.3 billion in 2023, representing a negative compound annual growth rate (CAGR) of 4% between 2018 and 2023.
- Market consumption volumes declined with a negative CAGR of 0.1% between 2018 and 2023, reaching a total of 25.7 million subscriptions in 2023.
- In 2023, the Kazakhstani wireless telecom market experienced a decline in traditional voice and messaging revenues due to the rise of OTT applications like WhatsApp, Telegram, and Viber. However, the data segment experienced robust growth due to increased mobile internet penetration, smartphone adoption, and a growing appetite for digital content and services.
