- The Nigerian wireless telecommunication services market recorded revenues of \$6.1 billion in 2023, representing a compound annual growth rate (CAGR) of 0.9% between 2018 and 2023.
- Market consumption volume increased with a CAGR of 6.6% between 2018 and 2023, to reach a total of 224.8 million subscriptions in 2023.
- Nigeria captured a share of 0.8% in the global telecommunication services market, in 2023.
