- Market consumption volume increased with a CAGR of 0.3% between 2018 and 2023, to reach a total of 40.6 million subscriptions in 2023.
- The Peruvian wireless telecommunication services market growth is attributed to increasing mobile subscriptions, growing advancements in wireless technologies such as 5G, and evolving data consumption demands by consumers.
