- Market consumption volume increased with a CAGR of 6.9% between 2018 and 2023, to reach a total of 37.4 million subscriptions in 2023.
- According to GlobalData, in 2023, the Netherlands accounted for a share of 2.9% of the European wireless telecommunication services market and is witnessing significant growth.
