Compared to 2023, retail demand for edible oils in Hong Kong is decreasing, while the category is recording low single-digit retail value growth. The latter is being driven by further price increases, due to stagnating global palm oil production, which is reflected in the growth of the Consumer Price Index for edible oils. Extreme weather conditions worldwide have particularly impacted olive production, leading to a significant increase in olive oil prices.
