In 2024, sweet spreads in Australia is experiencing low retail volume growth of 1%, but higher value growth of 5%. The category is not particularly benefiting from the trend of greater meal preparation at home, largely because Australians are becoming more mindful of their sugar intake. With rates of obesity and diabetes in the country rising, many consumers are moving away from high-sugar products such as jams and preserves and chocolate spreads, opting for healthier alternatives instead.
