Overall, sweet spreads are perceived as less essential than, say, edible oils or cooking sauces, and so this is an area where consumers can easily cut back or trade down to cheaper options and/or lower quantities. Honey recorded the weakest performance in sweet spreads with the higher average price of honey denting its...
