After a challenging 2023, when the average unit price of baked goods in Mexico recorded a third consecutive year of double-digit growth, it is experiencing a much slower rise in 2024, leading to slower value growth. In 2023, despite a contraction in the international price of grains, prices for end consumers of baked goods in Mexico continued to climb. This was partly due to pre-orders made by leading manufacturers of key ingredients such as wheat.
