With the economy still spluttering and consumer confidence still low, edible oils in Estonia in 2024 is expected to register modest current value growth, though volume sales are expected to fall. The performance is particularly bad for olive oil. Significant price increases for olive oil due to a bad harvest in Spain, see volume sales fall significantly. Spanish olive oil dominates in Estonia, with the Borges brand accounting for nearly half of value sales.
