Overall, sweet spreads is expected to register moderate current value growth and a slight increase in volume sales. Honey continues to account for most value sales, but volume growth is minimal in what is a mature product area. While value sales are less for jam and preserves, it is expected to register higher volume growth in 2024. Part of the reason for this is with sugar prices and also berry rising significantly, it is more economical to buy commercial jams and preserves, rather than make it...
