Sweet spreads recorded double-digit retail value sales in 2024 while recording low-level retail volume sales. Retail volume sales were heavily impacted by the rising price of cocoa. The price rise in coca was due to a low global yield of cocoa production in 2023/2024, resulting in a global price increase. With price sensitivity in place in Turkey, the growth of chocolate spreads has been limited. As chocolate spreads account for almost 60% of total category volume and 50% of retail value sales,...
