The feminine hygiene industry within the NAFTA countries had a total market value of \$6,883.6 million in 2023. The Canada was the fastest growing country, with a CAGR of 4.9% over the 2019-23 period.
- Within the feminine hygiene industry, the US is the leading country among the NAFTA bloc, with market revenues of \$5,892.7 million in 2023. This was followed by Canada and Mexico, with a value of \$553.9 and \$437.1 million, respectively.
- The US is expected to lead the feminine hygiene industry in the NAFTA bloc, with a value of \$7,441.2 million in 2028, followed by Canada and Mexico with expected values of \$676.0 and \$562.0 million, respectively.
